

Academic Appeals

This guidance can be read in conjunction with the University's full <u>Academic Appeals Regulations</u>. You can also refer to the University's <u>Guidance Leaflet</u>.

What is an academic appeal?

An 'academic appeal' is a request for the review of a final decision made by a Progression and Award Board. We advise that you first raise your concerns informally with your Faculty if you think there has been a misunderstanding that can be resolved with an immediate explanation.

An appeal can be submitted as an individual or collectively if an issue has affected two or more students, in this case the group should nominate a lead spokesperson, with whom the University shall liaise in the first instance.

What are the grounds for appeal?

Your appeal must meet at least one of 3 grounds:

- a) Exceptional circumstances affected your performance (you will need compelling evidence explaining why you did not or could not follow the Extenuating Circumstances Policy at the time of your assessment)
- b) You have evidence of the University not following their policies, resulting in you being disadvantaged
- c) You have significant evidence of prejudice or bias (this must be based in fact, not opinion)

What should you be aware of?

You cannot appeal on the grounds that you did not understand or were not aware of University regulations, policies or procedures. It is not possible to request for marks to be changed or work to be re marked. If your appeal is successful you may be able to submit a second attempt or permitted to complete one of more assessments, allowing you the chance to improve your results. If you're unhappy with a mark you receive during the academic year, we would encourage you to seek feedback from the marking tutor.

What is the process?

Complete the online <u>Academic Appeal Form</u> within 10 working days of the date of letter confirming the decision of the Progression and Award Board. You'll be asked to write a statement and include what you wish the outcome of your appeal to be. You'll also need to provide relevant supporting evidence.

On receipt of the appeal the Investigating Officer shall initially determine whether your appeal has been submitted within the time limit, on the correct form and in English. If your appeal does not conform to this criteria it shall be rejected.

The Investigating Officer may ask you to provide additional evidence or they may contact your Faculty for more information. If the appeal has grounds the matter will be referred to the Academic Registrar to decide the outcome of your appeal.

You will be informed by email if your appeal is unsuccessful. If you wish to challenge the decision you must complete the appeal review form within 10 working days from the date of the letter dismissing your appeal. If you remain dissatisfied you can take the appeal to the OIA.
